Overview of Rules

- All cooking spaces will be pre-assigned by TRAAC staff.
- All teams are asked to respect the rights of all other teams. Please respect others spaces by not infringing on adjacent spaces with your equipment and supplies. The Team Leader will be responsible for the conduct of his/her team and guests.
- TRAAC reserves the right to make additional rules and regulations as the situation warrants. Decisions of the TRAAC Staff and judges are final.
- If a team decides to withdraw, they must notify brian@tricountyaac.org more than seven days prior to the competition.
- The site coordinator will direct you to your site. Each team may check in on Saturday starting at 9:00am. Please be sure that you are set up and ready to cook by 12pm. No entry for set-up will be permitted after 11:30am.
- Each team is responsible for bringing their griddle or cooking and serving equipment, serving supplies, such as: plates, paper cups, napkins, utensils and ingredients.
- A tent is recommended but not required. Each team is responsible for bringing their own tent.
- Each team will be provided with a 10'x10' site, a table, two chairs, plastic covering and tabletop signage. The team shall provide all equipment and supplies including extension cords. Power can be provided at each site, upon request.

- Aprons and hats must be worn by all cooks. Barehand contact with exposed, ready-to-eat food is prohibited. A barrier, such as tongs, wax tissue or food service gloves must be provided to your personnel. Special attention to cleanliness of the cooking area and personnel is required.
- Each team will be responsible for the removal of their cooking equipment and supplies, as well as, the clean up of their site at the completion of the contest. All waste must be disposed by an approved method.
